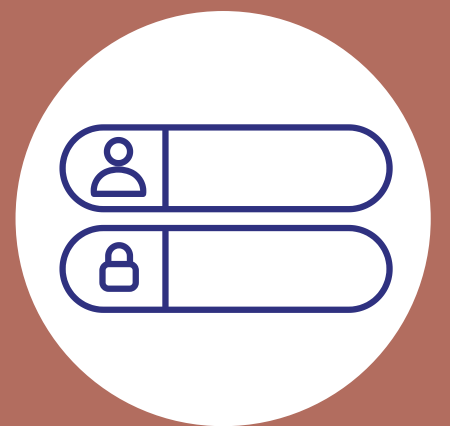


VISIT TOUCHPOINT WEBSITE

CREATE ACCOUNT

If you do not have a Touchpoint account, please set up a username and password and follow the prompts to create your profile. If you already have your login credentials, simply sign in to access your account.



CONFIRM THEIR RECURRING GIVING INFORMATION

Please review and confirm your recurring giving details—some credit cards have expired, and updating your information ensures your ongoing donations are processed correctly.

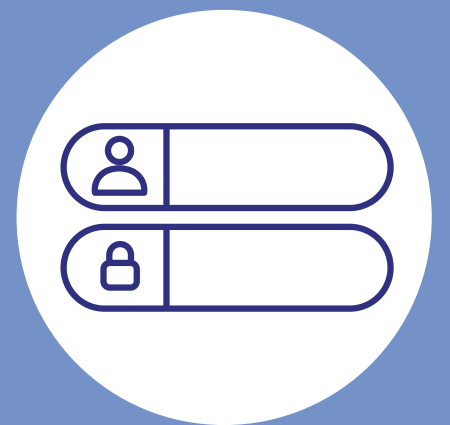

HOW TO ACCESS END-OF-YEAR TAX STATEMENT



ACCESS YOUR TOUCHPOINT ACCOUNT

Log in to your TouchPoint account. If you do not have an account, please visit TouchPoint and follow the prompts to create your profile.



ACCESS YOUR CONTRIBUTIONS

Once you have access to your account, click on the "Giving" tab, then select the "Contribution" tab. In the "Filter by Year" field, make sure the correct year is selected.

VIEW AND SAVE YOUR STATEMENT

Go to the "Statement" tab, click on the current year, and your statement will appear — you can then save or print it.

YEAR-END DONATIONS

Please keep in mind that any donation to Prince of Peace received before December 31st, 2025, or if mailed postmarked on or before December 31st, can be claimed as a 2025 tax deduction. In addition to giving through collections during Mass, please consider the following easy ways to donate:



TOUCHPOINT GIVING PAGE ONLINE

Signing up for one-time or recurring on-line donations is easy. Just visit our website at <https://www.popplano.org/give>. Both ACH and credit card options are available.



E-BANKING

If you wish to donate through your personal bank's Bill Pay system, simply set us up as a 'vendor' with the following address: 5100 W. Plano Pkwy, Plano, TX 75093. Please enter your envelope number and/or giving fund when prompted to enter a vendor account number.



IRA DONATIONS

If you are age 70½ or older, you can make a Qualified Charitable Distribution (QCD) of up to \$100,000 directly from your IRA to Prince of Peace—without including the amount in your taxable income, allowing you to support the parish while potentially lowering your tax liability. To initiate a QCD, contact your IRA custodian and include the date of the donation, your name, and your intended fund allocation.



STOCK DONATIONS

If you would like to make a stock donation to Prince of Peace Catholic Church, please visit our "Ways to Give" webpage on our website to access the Stock Donation Form and forward any transfer details to ensure proper fund allocation. Donors should include the date of the stock donation, their name, the stock name, and the number of shares donated.



EMPLOYER MATCHING GIFT PROGRAMS & VOLUNTEER GRANTS

Many companies offer matching gift programs, volunteer grants, or special funding opportunities that can increase the impact of your giving to Prince of Peace. Check with your employer to see if they participate, and be sure to include the date of your donation, your name, and your intended fund allocation.
